- 5. Discussion of City Procedures and Progress
  - a. City Clerk Report Gibbs reported that she spoke to a few more residents regarding the South Street Reconstruction project. She will be calling a meeting of the Planning and Zoning Commission soon to move forward with re-zoning a portion of East Hwy 2.
  - b. Public Works Report Chambers reported that the pool is up and going. It's not leaking as much and the crew is narrowing down the location of the leak. The crew has ground several stumps at the golf course and dressed up the areas around the playground equipment. He reported that the greens mower is showing a lot of wear the city may need to replace before next season. Due to all of the trees that have had to be removed at Walden Park, Chambers suggested putting together a tree replacement plan. He reported that there was a pre-construction meeting with Hydro-Klean for the next round sewer main cleaning/televising. That will begin the week of June 30. Finally, Chambers thanked Kenny Holmes and his family for the new landscaping at the pool sign.

- 6. Give Audience to Wayne County Fairboard regarding Adding Lights to Fairgrounds Ballfield Poles and Tornado Siren Pole.

Dan May and Chad Lukvasky asked permission to install LED lights at the city little league field and new tornado siren pole to help light parking areas for the Wayne County Fair. The lights would only be used during the fair. The council had no issues with the request.

Give Audience to David Rhoades, Wayne County Environmental Health, Regarding Well Grants Dave Rhoades shared with the council that his department has funds available to assist city residents with wells and cisterns on their property. - 11. Consideration/Approval to Request Bids for Dead/Diseased Tree Removal in City Right of Way Gibbs reviewed the bid proposal to have trees removed over multiple fiscal years.
