1. Call to Order/Roll Call

This change would allow commercial businesses and would match the south side of Hwy 2. Members of the public were present with questions regarding the changes. The council assured her that this is not the case and that re-zoning only allows certain commercial use of a property, if the owner chooses, in addition to residential.
