AN ORDINANCE AMENDING CHAPTER 13.16.040
OF THE CORYDON MUNICIPAL CODE

Be It Enacted by the Council of the City of Corydon, Iowa:

Section 1. Purpose. The purpose of this ordinance is to AMEND Chapter 13.16.040 of the Corydon Municipal Code to increase the charge for use of the municipal sewer system.

Section 2. Amendment. Chapter 13.16.040(A) of the Corydon Municipal Code is hereby deleted in its entirety and replaced with the following:

13.16.040 • User charge. Each user shall pay for the use of and for the service supplied by the municipal sewer system of the city as follows:

- A. The minimum charge per month for all users shall be fifty-four dollars (\$54.00) per month. Each user shall also pay an additional monthly user charge for operation, maintenance and replacement of the sewer system at the rate of eight dollars and sixty-four cents (\$8.64) per month for each one thousand (1,000) gallons in excess of two thousand five hundred (2,500) gallons of water used as determined by the water meters acceptable to the city showing the amount of water consumed.

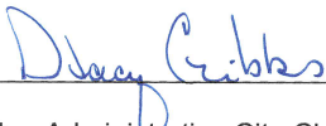
Section 3. Repealer. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 4. Severability. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

Section 5. Effective Date. This ordinance shall be in effect after its final passage, approval, and publication as provided by law.

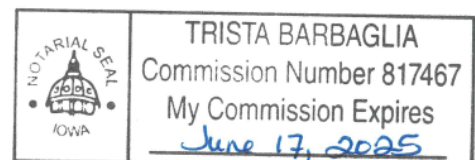
